In this class, one can expect to read a variety of fiction and non-fiction text including novels, short stories, and poetry. These writing pieces will model the different writing styles we will be working on ourselves. Writing assignments will include journal writing, essays, critiques, and creative pieces. Vocabulary and spelling will also be an important part of this class. Because we are a community of learners, The students will be instructed on how to use, create and evaluate parts of speech, paragraphs, types of writing and specific words.
